

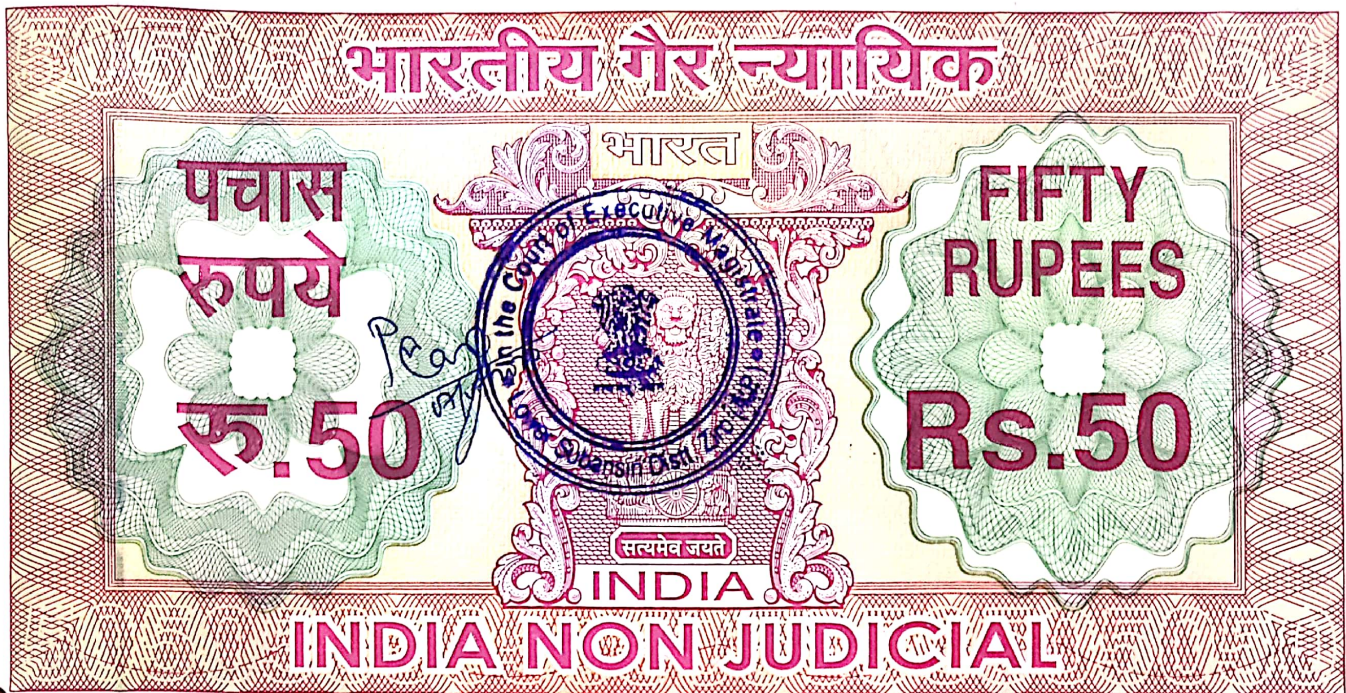
That DON BOSCO SOCIETY is a registered Society under the Regd. No. SR / ITA / 1525

13. That the school shall strive to make efforts for conservation of environment.

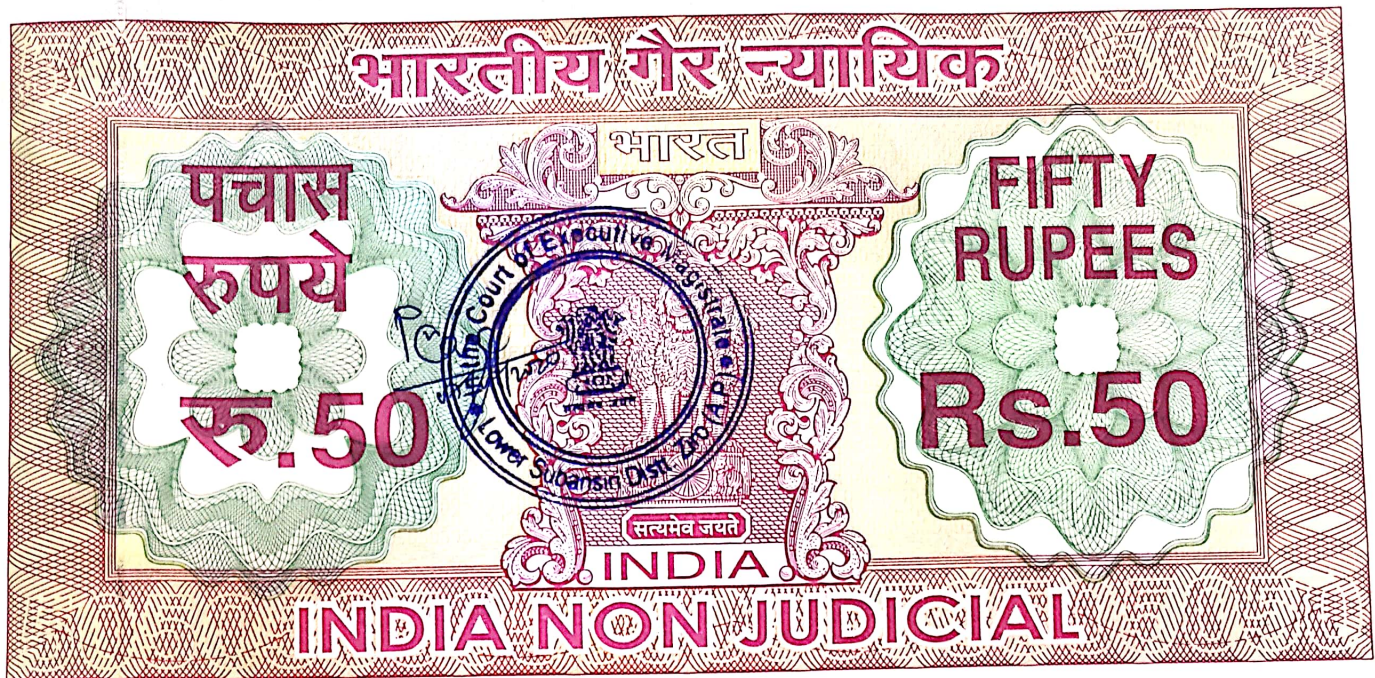
